



## NOTICE OF RACE

---

The Farr 40 Owners' Group of Australia invites entries to the Farr 40 Australian Open Series National Championships: John Calvert-Jones Trophy being sailed in Sydney on 29-31 January 2016.

### **1. ORGANISING AUTHORITY**

The Organising Authority (OA) is the Farr 40 Australia Association. The regatta will be hosted by the Middle Harbour Yacht Club (MHYC) which is located at Lower Parriwi Road, The Spit, Mosman NSW 2008.

### **2. RULES**

2.1 This Regatta will be governed by:

- The rules as defined in the 2013-2017 Racing Rules of Sailing (RRS) of the International Sailing Federation;
- The rules and regulations of the Farr 40 One Design Class;
- The prescriptions and special regulations of Yachting Australia;
- This Notice of Race, except as any of these are modified by the Sailing instructions.

2.2 The OA reserves the right to amend this Notice of Race. Amendments will be published on the Official Noticeboard and on the Events Website [www.farr40.asn.au](http://www.farr40.asn.au).

### **3. RACING RULES OF SAILING - CHANGES**

- 3.1 Remove the second sentence of RRS 30.2 and replace with the following: *"If a boat breaks this rule and is identified she shall receive, without a hearing, a 10% scoring penalty calculated as stated in rule 44.3(c)".*
- 3.2 Delete the first and second sentences of RRS 44.1 and substitute the following: *"A boat may take a One-Turn Penalty, consisting of one tack and one gybe, when she may have broken a rule of Part 2, Rule 31 or Rule 42 while racing. However, if a boat may have broken a rule of Part 2 within the zone of a rounding mark or finish mark, the penalty that may be taken is a Two-Turns Penalty".*
- 3.3 The maximum amount of drinkable liquid aboard each yacht shall not exceed six (6) litres per person, per day. This liquid is included in the restrictions for movable ballast in RRS 51.
- 3.4 Video, data and/or photographs taken from any source shall not be used as evidence at protest hearings. This changes RRS 63.6.
- 3.5 Except on a beat to windward, the boat's crew may pull in any sail any number of times in order to initiate or to maintain surfing or planing.

### **4. ELIGIBILITY**

- 4.1 This regatta is open to all Farr 40 yachts as defined by the Class Rules. Owners, Charterers and Substitute helmsman shall be current members of the Farr 40 Class Association, and a member of a Yacht or Sailing Club recognised by Yachting Australia or an equivalent national authority.

4.2 Yachts shall comply with the Yachting Australia Special Regulations Category 4.

### **5. ENTRY DOCUMENTATION AND REGISTRATION**

5.1 Entry forms for the 2015/16 Farr 40 Australian Open Series are available at [www.farr40.asn.au](http://www.farr40.asn.au)

5.2 Entries shall be submitted to Jennie Hughes E: [farr40australia@gmail.com](mailto:farr40australia@gmail.com) no later than Friday, 22 January 2016. Late entries will be accepted, however an additional fee of \$250 AUD will be charged for late entries.

5.3 Entries shall include the following documentation:

- a) Completed entry form submitted to Farr 40 Class Administrator
- b) The entry fee of \$1,500 AUD payable to the Farr 40 Australia

5.4 Registration shall be completed with the Australian Class Administrator as described below. Sail declarations may be made on site during registration. All entries shall have completed the following:

- a) Entry form with Class Administrator, including payment of all fees
- b) 2015/16 One Design Certificate issued by Stag Yachts
- c) 2015/16 Australian Class membership
- d) Crew ISAF classification declared on the Crew Declaration Form
- e) Sail declaration form
- f) Appendix 10 – Yacht Owner Compliance form
- g) Yachting Australia Special Regulations Equipment Audit Form Category 4.

6.2 The Race Committee intends to conduct as many races as practicable on each scheduled day of racing, up to a maximum of ten races for the series. The initial warning signal for racing each day will not be made before 1100hrs and no warning signal will be made after 1500hrs on the last scheduled day of racing.

6.3 Races will be conducted 'back-to-back' and races subsequent to the first race of the day will be started as soon as practicable after the completion of the previous race.

6.4 After consultation, the PRO may modify the above programme according to prevailing weather conditions and/or other unforeseen circumstances.

**7. MEASUREMENT AND INSPECTION**

7.1 Crew members who weigh-in for the NSW State Title will be deemed to have weighed-in for the National Championships, unless they elect to present again for weigh-in. New crew members will be weighed on official scales at the Members Room, MHYC.

7.2 Full measurement is not required, but all boats shall conform to the Class Rules of the Farr 40 One Design Class. The Race Committee may inspect any yacht prior to or during the regatta for Special Regulation and Class Rule compliance.

**8. EVENT ADVERTISING**

Each yacht may be required to display event advertising on the bow, boom, backstay and/or forestay.

### **9. SAILING INSTRUCTIONS**

The Sailing Instructions will be available after 1300 on 25 January 2016 at the MHYC Sailing Office or via the MHYC website: [www.mhyc.com.au](http://www.mhyc.com.au). The Class Administrator will circulate the Sailing Instructions via email and they will also be published on the Farr 40 Australia website: [www.farr40.asn.au](http://www.farr40.asn.au)

### **10. COURSES AND RACING AREA**

10.1 An inshore and offshore course will be set for this regatta as follows:

- a) The Sound, Sydney Harbour in the vicinity of the MHYC race area (see Attachment 1)
- b) Manly Circle (see Attachment 2)

10.2 The courses to be sailed will be windward/leeward races as outlined in the Sailing Instructions.

### **11. PENALTIES**

The penalty, if any, for any infringement of the rules (including the Class Rules and Yachting Australia Special Regulations Category 4) other than RRS Part 2 is at the sole discretion of the Jury in consultation with the Class representative, and may be other than disqualified. This changes RRS 64.1.

### **12. SCORING**

12.1 Four (4) races are required to be completed to constitute a series.

12.2 There will be a maximum of ten (10) races.

12.3 Each yacht's score shall be the sum of all her races (no discards).

### **13. PRIZES**

13.1 1st Place – Farr 40 Australian Champion

13.2 2nd Place and 3rd Place

13.3 Corinthian Division Winner

### **14. BERTHING**

14.1 All boats are required to be berthed at the MHYC Marina.

14.2 Limited casual berthing and moorings are available to boats competing. All requests for casual berthing and moorings shall be made by completing the 'Casual Berthing Registration' form available from the MHYC Website [www.mhyc.com.au](http://www.mhyc.com.au)

14.3 The MYHC will be responsible for the assignment of mooring positions for all entrants. All entrants will be notified on their arrival at the MHYC for their mooring position.

14.4 Should a mooring be required for a longer period, entrants may extend the booking by contacting Matthew Pyne at the MHYC Marina Office on T: 02 8969

3114. Extended bookings will be chargeable at the current marina rates. Early booking is recommended.

### **15. SUPPORT BOATS**

Competitor's attention is drawn to the applicable Class Rules and Interpretations.

*"A yacht shall receive no outside assistance from support boats or otherwise once she has left the dock for the day until the finish of the last race of the day, except in the case of emergency."*

### **16. HAUL-OUT RESTRICTIONS**

Boats shall not be hauled out during the regatta except with and according to the terms of prior written permission of the Race Committee.

### **17. MEDIA & IMAGE RIGHTS WAIVER**

17.1 The Media Centre will be at the Regatta Office. Attendance at a media/press conference each day may be required for the top three competitors as well as individual heat winners. Suitable notification will be given.

17.2 By entering this regatta, the Owner (or Charterer) and Crew members on competing yachts grant, at no cost, the absolute right and permission to use their names, voices, images, likenesses, and biographical material, as well as representations of their yacht in any media (including television, print and internet), to the Farr 40 Class Association, the Farr 40 Management Group, Staggs Yachts, the Farr 40 Executive Committee, affiliated companies and other sponsors.

17.3 The Farr 40 Class Association, the Farr 40 Management Group, Staggs Yachts, the Farr 40 Executive Committee, affiliated companies and other sponsors shall not use the names, voices, images, likenesses or biographical material of an Owner (Charterer) or Crew member in a way that constitutes an endorsement of products unless the competitor or crew member is otherwise engaged by or affiliated with companies to endorse products or otherwise gives his/her prior written consent to such use.

17.4 Owners (Charterers) and Crew members shall acknowledge and accept the granting of media rights referred to in this paragraph 17 by signing the Entry Form and the Disclaimer and Acknowledgement of Rights Form provided by the Class Administrator Jennie Hughes.

### **18. DIVING EQUIPMENT AND PLASTIC POOLS**

Plastic pools or their equivalent shall not be used around keelboats between the preparatory signal of the first race and the end of the regatta.

18.1 Boats that are stored in a sea pen or other similar enclosed dry dock system may utilise the device closed but fully flooded and shall be determined to be in compliance. No chlorine or other antifoul material shall be added to the closed device.

18.2 Boats that use a boat bag or boat bath device that utilises chlorine within the flooded bag when closed, may remain in the bag provided the bag is left fully open and no chlorine or other antifoul material is added within the time limits above. By doing this, they shall be deemed to be in compliance. The bag shall be tied open. Closing the bag system shall be deemed to be non-compliant.

### **19. RADIO COMMUNICATION**

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

### **20. DISCLAIMER OF ENTRY**

20.1 The Owner (Charterer) and each Crew member:

- a. Acknowledges and accepts the risks (including the risk of harm to persons and property and the risks associated with the perils of the sea and the seaworthiness of any boat) associated with participation in this regatta and waives all rights against and releases the Farr 40 Class Association, the Farr 40 Management Group, Stagg Yachts, the Farr 40 Executive Committee, any sponsors and their respective officers, employees, volunteers and members in respect of any loss of life or injury to persons, or loss of or damage to property, suffered in connection therewith;
- b. Acknowledges that participation in this regatta by him or her is on the basis that participation is entirely at his or her risk and responsibility and that the Farr 40 Class Association, the Farr 40 Management Group, Stagg Yachts, the Farr 40 Executive Committee, any sponsors and their respective officers, employees, volunteers and members are not responsible for any boat or its crew;
- c. Acknowledges and agrees that this form is governed by the laws of Australia and that any liability for harm to persons that results from breach of an express or implied warranty that this regatta and all services relating thereto will be conducted or rendered with reasonable care and skill is excluded.

20.2 Competitors participate in the regatta entirely at their own risk. The OA will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.

20.3 All competitors shall acknowledge this by signing the Disclaimer and Acknowledgement of Rights Form provided by the OA.

20.4 Competitors attention is drawn to RRS 4 'Decision to Race'. *"The responsibility for a boats' decision to participate in a race or to continue racing is hers alone."*

### **21. INSURANCE**

21.1 The safety of a boat and her entire management shall be the sole inescapable responsibility of the Owner/Charterer/Owners' representative. It is the

responsibility of the Owner to provide insurance for the yacht covering eventual damage to persons or property.

21.2 The boat is required to hold adequate insurance including third-party insurance of minimum cover of \$10,000,000 AUD, and it is the Owner's or Owners' representative's sole and inescapable responsibility to ensure that the insurance is in place and is adequate prior to participating in this event.

### **22. PRINCIPAL RACE OFFICER**

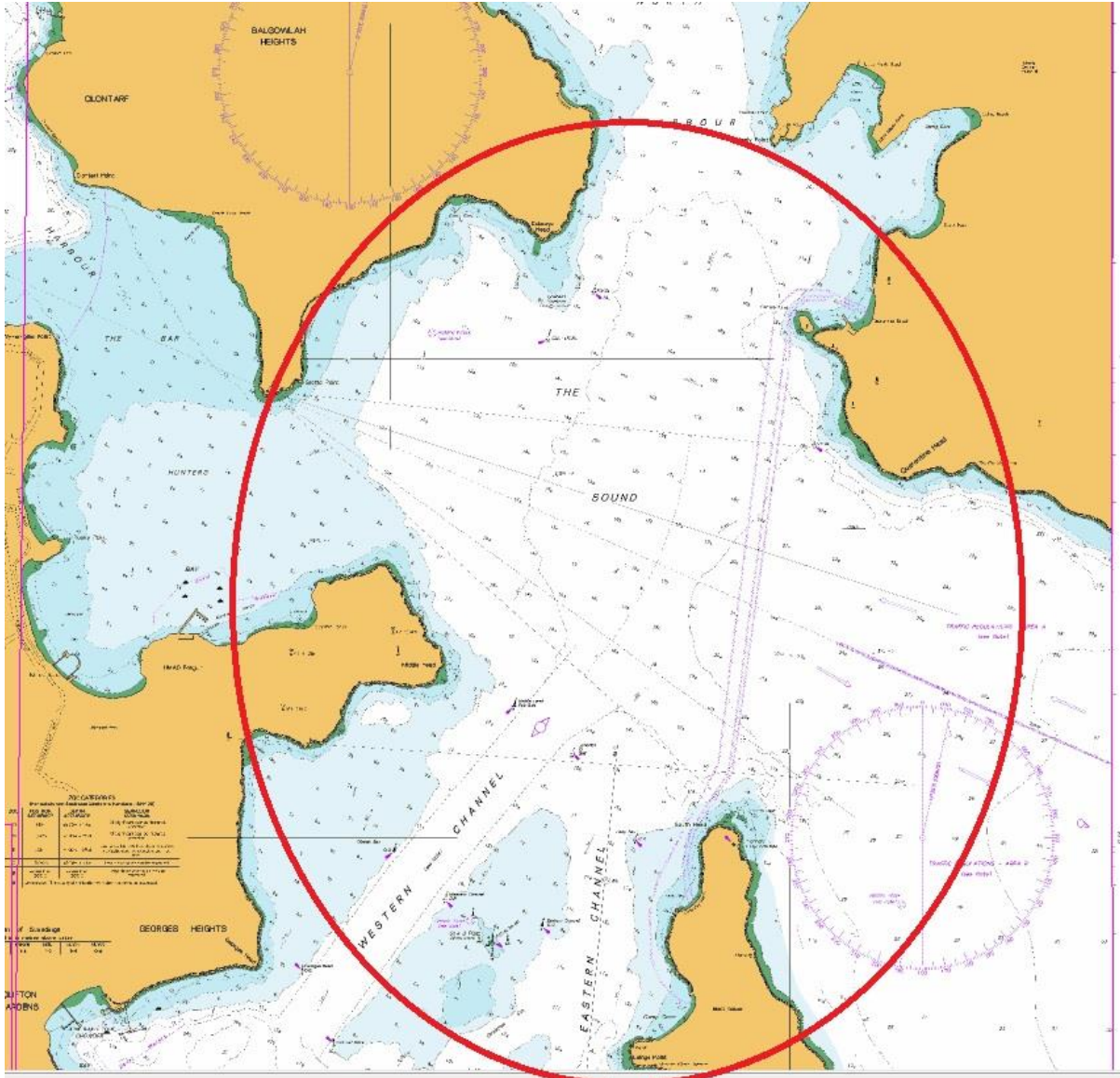
